

These include CARBOWAX PEGs of molecular weight 300 to 1000, and CARBOWAX MPEG 350 and 550. Our premium SENTRY line of CARBOWAX PEGs and MPEGs is compliant with the most recent version of the National Formulary (NF) monograph for polyethylene glycols, which is so designated in the product name as NF grade. Additionally, applicable molecular weight grades of CARBOWAX SENTRY PEGs are further compliant with the requirements of the most recent version of the European Pharmacopoeia (Ph. Eur.) monograph for Macrogols, and are so designated in the product title as Ph. Eur. grades.

The Dow Chemical Company manufacturing facility at our Plaquemine, Louisiana plant producing the low molecular weight CARBOWAX SENTRY PEGs is fully compliant with current good manufacturing practices (cGMP) in accordance with the International Pharmaceutical Excipients Council (IPEC) Guide for Bulk Pharmaceutical Excipients. The CARBOWAX SENTRY PEG and MPEG facility at The Dow Chemical Company, Plaquemine Operations site is not registered with the U.S. Food and Drug Administration (FDA). No Finished Drug Products or Active Pharmaceutical Ingredients are manufactured at this location. Therefore this site is not required to be registered as a Drug Establishment. There have been no Form 483 – Inspectional Observations or other violations from the FDA for the CARBOWAX PEG and MPEG facility at Plaquemine Operations.

CARBOWAX SENTRY PEGs are packaged at a third party contractor, Delta Companies Group located in St. Gabriel, Louisiana. This packaging facility is ISO 9001:2008 certified and operates under current guidelines found in Joint International Pharmaceutical Excipients Council (IPEC) — Pharmaceutical Quality Group (PQG) Good Manufacturing Practices Guide for Pharmaceutical Excipients (2006).
