GOOD MANUFACTURING PRACTICE COMPLIANCE STATUS

We refer to your company's application for a new GMP certificate (Application No. 19D8900M) and the subsequent correspondences.

2 MSD International GmbH (MSD) which is located at 50 Tuas West Drive Singapore 638408, is a manufacturer of chemical drug substances (as active pharmaceutical ingredients). The company holds a GMP Certificate, MCGM1700252, issued by the Health Sciences Authority, which attested its conformity to the Pharmaceutical Inspection Convention/Co-Operation Scheme (PIC/S) Guide to Good Manufacturing Practice for Medicinal Products (Part II) and the relevant annexes in the manufacture of active pharmaceutical ingredients. The last inspection was conducted on 6 to 9 June 2017 and the GMP certificate remains valid until 5 June 2020.

3 MSD has submitted an application for a new GMP certificate and an on-site GMP inspection by the HSA was initially scheduled to take place from 21 April to 24 April 2020. In the light of the nation-wide implementation of Circuit Breaker measures on 7 April 2020 by the Government to mitigate the risk of transmission of Covid-19 infection, the HSA is mindful of the potential impact of an on-site GMP inspection on the health and safety of all personnel involved where safe distancing may be difficult to achieve.

4 Given the exceptional circumstances, the HSA has performed a desktop assessment in lieu of an on-site GMP inspection of MSD. From the knowledge gained in the assessment, MSD is deemed to be operating in continued compliance with the PIC/S GMP requirements while taking into consideration of the satisfactory history of compliance of MSD in the past inspections by the HSA. Notwithstanding, in relation to the pending application for a new GMP certificate, the HSA will conduct an on-site GMP inspection of MSD's manufacturing site at an appropriate time when the Covid-19 pandemic restrictions are lifted.

5 Additionally, we noted that MSD has been inspected recently by a number of PIC/S Participating Authorities including the Japan Pharmaceuticals and Medical Devices Agency (PMDA) and United States Food and Drug Administration (US FDA) with satisfactory outcome.

6 This letter reflects the status of the MSD's manufacturing site at the time of assessment noted above in paragraph 4 and the company's GMP compliance status remains valid for 12 months from the date of this letter.
