- 5) Specific permission for each export order need not be obtained. However, the details of exports by the exporter shall be furnished immediately after completion of each export in the format mentioned below.

- 7). The specification/standards asked for by the Importing Country/firm shall be complied with while exporting the drugs.
- 8). The federal regulations of the importing country shall be fulfilled while exporting/supplying the drugs.

In case of Narcotics/Psychotropic Drugs, you are also directed to approach the Narcotic Commissioner of India, 19th The Mal Morar, Gwalior-6 so far as the provisions of the NDPS Act and the Rules are concerned in the matter.
