Section 4. First Aid Measures

Routes of Exposure:

If in Eyes	Rinse eyes thoroughly with lukewarm water for at least 15 minutes. Do not allow the person affected to rub or close their eyes. If the injured person uses contact lenses, these should be removed unless they are stuck to the eyes, in which case this could cause further damage. In all cases, after cleaning, immediately call a POISON CENTER or doctor/physician. Seek medical advice.
If on Skin	Remove contaminated clothing and footwear, rinse skin or shower the person affected if appropriate with plenty of cold water and neutral soap. For minor skin contact, avoid spreading the material to unaffected areas. Contaminated clothing should be washed separately before reuse. In serious cases see a doctor. If the product causes burns or freezing, clothing should not be removed as this could worsen the injury caused if it is stuck to the skin. If blisters form on the skin, these should never be burst as this will increase the risk of infection. Immediately call a POISON CENTER or doctor/physician.
If Swallowed	Do not induce vomiting. Wash out mouth thoroughly with water. Never give anything to the mouth of an unconscious person. If vomiting occurs, place victim face downwards, with the head turned to the side and lower than the hips to prevent vomit entering the lungs. Seek medical attention.
If Inhaled	Move the person to fresh air immediately. Remove contaminated clothing and loosen remaining clothing. Allow person to assume most comfortable position and keep warm. Keep at rest until fully recovered. Administer oxygen or artificial respiration if necessary. Symptoms may be delayed—keep the person under observation and seek medical advice immediately if breathing becomes difficult or has stopped.

Special hazards arising from the substance	The substance's vapour and air mixtures are highly flammable and explosive. Containers where the substance is stored may explode when heated As a result of combustion or thermal decomposition, reactive sub-products are created such as Carbon monoxide (CO) and Carbon dioxide (CO₂) that can become highly toxic and, consequently, can present a serious health risk.

Precautions for firefighters and special protective clothing	In case of fire and/or explosion do not breathe fumes. Co-ordinate firefighting measures to the fire surroundings. Do not allow firefighting water to enter drains or water courses. Collect contaminated firefighting water separately. Fight fire with normal precautions from a reasonable distance. Depending on the magnitude of the fire it may be necessary to use full protective clothing and self-contained breathing apparatus (SCBA). Minimum emergency facilities and equipment should be available (fire blankets, portable first aid kit) in accordance with Directive 89/654/EC.

Section 6. Accidental Release Measures

Always ensure your own individual safety first before assisting others. Wear protective gear as detailed in Section 8. Evacuate all unnecessary personnel. Avoid contact with skin and eyes.

Beware of vapours accumulating which may form explosive concentrations. Ensure adequate ventilation to the affected area, ventilate closed spaces before entering, and remove all sources of ignition if safe to do so.

For emergency responders, wear breathing apparatus if exposed to vapours/gases. For environmental protection, do not allow any discharge to enter drains and water courses.

Methods and materials for containment and clean up:

1. Stop and think! Ensure your own safety first above all else.
2. Identify and wear the correct PPE gear required. Refer to Section 8.
3. If safe to do so, isolate the substance, shut off all nearby ignition sources, cover all nearby drains to protect the waterways, and stop the source of the leak.
4. If required, ring 111 or escalate the spill emergency.
5. Clean up the substance by using inert absorbent material (e.g absorbent pads, loose absorbents, absorbent peat, universal binder) and move all contaminated materials in appropriate containers for disposal.
6. Dispose the substance as per Section 13 and ventilate the affected area.
7. Restock your spill kits and review. It's important that you share your knowledge so that the spill doesn't happen again.

Section 7. Handling and Storage

Precautions for Handling:

- Read label before use.
- Use spark-proof tools and mechanical equipment.
- Take suitable precautions to prevent the build-up of electrostatic charge.
- Do not inhale fumes, gas, mist, vapours or spray.
- Ensure adequate ventilation in the area before handling.
- In case of insufficient ventilation, wear suitable respiratory equipment.
- Avoid heat, hot surfaces, open flames, and other ignition sources when handling.
- No smoking near the substance.
- Wear protective clothing as detailed in Section 8.
- Keep containers hermetically sealed.
- Control spills and residues, destroying them with safe methods.
- Avoid leakages from the container.
- Maintain order and cleanliness where dangerous products are used.
- Do not eat or drink while handling, and always wash hands with suitable cleaning products afterwards.

Precautions for Storage:

- Store away from incompatible materials listed in Section 10.
- Keep in tightly closed containers until required for use.
- Storage temperatures: Minimum = 5°C Maximum = 30°C
- Avoid sources of heat, radiation, static electricity and contact with food.
- Keep in a cool, well-ventilated area that has explosion-proof lighting and ventilation facilities
- Ensure that all storage areas have adequate fire-fighting equipment, emergency response spill kits, first aid kits, and other suitable containment materials.

Chemical Stability of Substance	This product is stable under normal conditions room temperature and pressure. Does not react with water and isolates.
Possibility of hazardous reactions	Under the specified conditions, hazardous reactions that lead to excessive temperatures or pressure are not expected. However, ethanol reacts slowly with calcium hypochlorite, silver oxide and ammonia. It also reacts violently with strong oxidants such as nitric acid, silver nitrate, mercuric nitrate and magnesium perchlorate. This will generate a fire and explosion hazard.
